MAJOR BID ITEMS will include: Mobilization - LS, Access – LS, Erosion and Water Pollution Control – LS, Roadway Excavation and Disposal 260 CY, Channel Excavation and Disposal – 700 CY, Removal of Structures–LS, Sheet Pile – 1200 sq ft, Streambed Gravel – 50 CY, Foundation Rock – 10 CY, Procure and Install Precast Backwall – LS, Select Borrow 25 CY, Crushed Surfacing 60 CY, Large Woody Debris 12, Site Restoration– LS and other items in conformance with the 2024 WSDOT Standard Specifications incl. the APWA Supplement, and the Special Provisions for this project.
